**TOWN OF WASHINGTON NO. 2 dated May 2009**

**AN ORDINANCE OF THE TOWN OF WASHINGTON ENLARGING AND EXTENDING THE BOUNDARIES OF THE MUNICIPALITY OF THE TOWN SO AS TO INCLUDE WITHIN THE CORPORATE LIMITS OF SAID MUNICIPALITY, AN ADDITIONAL LAND AREA CONTAINING 3.479 ACRES DESCRIBING WITH PARTICULARLY THE ADDITIONAL LAND AREA TO BE ANNEXED AND INCORPORATED INTO THE TOWN.**

**BE IT ORDAINED BY THE COUNCIL and/or BOARD OF ALDERMAN OF THE TOWN OF WASHINGTON, that:**

**WHEREAS**, in accordance with Louisiana Revised Statute 33:172, a petition has been filed by Gregory Doucet, Mary Renee Ortego Doucet, Isabelle McCauley Doucet, Sean Michael Doucet, and Leslie Michelle Vidrine Doucet, seeking to have property which they own to be annexed into the Town of Washington submitted at the regular meeting of the Council on January 20, 2004, it having been certified by the St. Landry Parish Registrar of Voters and the St. Landry Parish Assessor that the requirements of Louisiana Revised Statute 33:172 have been complied with and that all other requirements of law have been duly satisfied.

**WHEREAS**, it is deemed advisable, expedient and desirable to annex said property and being that this body has the delegated authority to adopt this Ordinance.

**NOW, THEREFORE, BE IT FURTHER ORDAINED** by the Mayor and Board of Aldermen of the Town of Washington, that:

**SECTION 1:**

That the boundaries and corporate limits of the Town of Washington, Louisiana, be expanded and enlarged to include within its corporate limits the property described on Exhibit AA@, attached hereto and made a part hereof.

**SECTION 2:**

That all of the property and territory described in Section I hereinabove is hereby declared to be within the Corporate Limits of the Town of Washington, Louisiana.

**SECTION 3:**

That this Ordinance be published once in THE DAILY WORLD, a newspaper having a general circulation in the Town of Washington, and that thirty (30) days after the date of said publication, this Ordinance shall become operative in accordance with Louisiana Revised Statute 33:173.

**SECTION 4:**

That all Ordinances, or parts of Ordinances, inconsistent or in conflict herewith are hereby repealed.

**SECTION 5:**

That should any provision of the Ordinance be found to violate the Constitution or be declared illegal for any reason, it shall not affect the other provisions of this Ordinance.


